# **About Company**

The AMAC Foundation provides valuable education and insight into Social Security benefit options to its constituency. Operation of the Social Security Report and Medicare Report websites provide breaking news on critical issues as a service to Congressional offices and concerned citizens, along with questions and answers on a variety of Social Security issues. In addition, the Foundation's staff now boasts seven accredited Social Security Advisors to provide research and counseling.

The Foundation's target constituency includes mature Americans age 50 and over, of all income and education levels. In addition, this audience includes anyone needing to have a complete understanding of Social Security and its related programs to help them achieve the maximum benefit to which they are or will be entitled. Demographically, the Foundation's target constituency is characterized by a set of statistics that fit well with the mission of service to mature Americans. Consider:

- 55.8 million Americans are 65 or older (16.8% of the US population; 2020 Census)
- 123 million Americans are ages 50+ (published Oct 2023 IBISWorld; sourced from US Census Bureau & IBISWorld)
- 2 million Americans age 55 and older are long-term unemployed
- 10.9% of Americans age 65 and over are below the poverty line (US Census estimate 2022)



# Social Security Advisory Service










The 2024 goals will expand the services, further connecting the AMAC Foundation nationwide on Social Security matters and issues important to Seniors. This goal will also extend to our Veteran resources and activities.

Responding to a common theme of increased costs due to inflation and decreased donations across non-profits nationwide, AMAC Foundation leadership analyzed operational costs and expense reductions for 2023 and 2024.

Throughout 2023, the executive team sought out agencies that would understand the vision and mission of the AMAC Foundation in anticipation of partnering on fundraising campaigns in 2024. Changes for 2024 will also include office relocation to reduce overhead and operational costs and an analysis of program and fundraising manhours.

The AMAC Foundation in-house team will continue to expand the Social Security Advisory Service, Senior services, and Veteran outreach through nationwide webinars, resource creation, and informational sessions. Consideration will also be given to increasing time spent on grant writing and internal donation campaigns.

As a 501(c)(3), the AMAC Foundation saw a need in 2022 for a donor management system. In 2023, they tested and implemented ELEO, which serves for donor management, event coordination, and more. The system proved useful in reaching over 35,000 individuals through mail and/or email during the 2023 annual campaign that was run by in-house personnel.

SSAS advisors began to break down the bewildering Social Security system into smaller topics for virtual presentations that will be delivered throughout 2024. "Ask Rusty - Gen X Spotlight" series was recorded and launched, introducing the world of Social Security to America's future retirees.
